

Chapter 111. Texas Essential Knowledge and Skills for Mathematics

Subchapter A. Elementary

§111.6. Grade 4

(a) Introduction.

(1) The ***desire to achieve educational excellence*** is the driving force behind the Texas essential knowledge and skills for mathematics, guided by the college and career readiness standards. By embedding statistics, probability, and finance, while focusing on computational thinking, mathematical fluency and solid understanding, Texas will lead the way in mathematics education and prepare all Texas students for the challenges they will face in the 21st century.

(2) The ***process standards*** describe ways in which students are expected to engage in the content. The placement of the process standards at the beginning of the knowledge and skills listed for each grade and course is intentional. The process standards weave the other knowledge and skills together so that students may be successful problem solvers and use mathematics efficiently and effectively in daily life. The process standards are integrated at every grade level and course. When possible,

- students will apply mathematics to problems arising in everyday life, society, and the workplace.
- Students will use a problem-solving model that incorporates analyzing given information, formulating a plan or strategy, determining a solution, justifying the solution, and evaluating the problem-solving process and the reasonableness of the solution.
- Students will select appropriate tools such as real objects, manipulatives, algorithms, paper and pencil, and technology and techniques such as mental math, estimation, and number sense, and generalization and abstraction to solve problems.
- Students will effectively communicate mathematical ideas, reasoning, and their implications using multiple representations such as symbols, diagrams, graphs, computer programs, and language.
- Students will use mathematical relationships to generate solutions and make connections and predictions.
- Students will analyze mathematical relationships to connect and communicate mathematical ideas.
- Students will display, explain, or justify mathematical ideas and arguments using precise mathematical language in written or oral communication.

(3) For students to become ***fluent in mathematics***, students must develop a robust sense of number. The National Research Council's report, "Adding It Up," defines procedural fluency as "skill in carrying out procedures flexibly, accurately, efficiently, and appropriately." As students develop procedural fluency, they must also realize that true problem solving may take time, effort, and perseverance. Students in Grade 4 are expected to perform their work without the use of calculators.

(4) The ***primary focal areas*** in Grade 4 are

- use of operations,
- fractions, and decimals
- and describing and analyzing geometry and measurement.

These focal areas are supported throughout the mathematical strands of number and operations, algebraic reasoning, geometry and measurement, and data analysis. In Grades 3-5, the number set is limited to positive rational numbers. In number and operations, students will apply place value and represent points on a number line that correspond to a given fraction or terminating decimal. In algebraic reasoning, students will represent and solve multi-step problems involving the four operations with whole numbers with expressions and equations and generate and analyze patterns. In geometry and measurement, students will classify two-dimensional figures, measure angles, and convert units of measure. In data analysis, students will represent and interpret data.

(5) Statements that contain the word "including" reference content that must be mastered, while those containing the phrase "such as" are intended as possible illustrative examples.

The student is expected to:</p> <p>(A) illustrate the measure of an angle as the part of a circle whose center is at the vertex of the angle that is "cut out" by the rays of the angle. Angle measures are limited to whole numbers;</p> <p>(B) illustrate degrees as the units used to measure an angle, where $1/360$ of any circle is one degree and an angle that "cuts" $n/360$ out of any circle whose center is at the angle's vertex has a measure of n degrees. Angle measures are limited to whole numbers;</p> <p>(C) determine the approximate measures of angles in degrees to the nearest whole number using a protractor;</p> <p>(D) draw an angle with a given measure; and</p> <p>(E) determine the measure of an unknown angle formed by two non-overlapping adjacent angles given one or both angle measures.</p> <p>4.8 The student applies mathematical process standards to select appropriate customary and metric units, strategies, and tools to solve problems involving measurement. The student is expected to:</p> <p>(A) identify relative sizes of measurement units within the customary and metric systems;</p> <p>(B) convert measurements within the same measurement system, customary or metric, from a smaller unit into a larger unit or a larger unit into a smaller unit when given other equivalent measures represented in a table; and</p>	<p>(C) compare the advantages and disadvantages of various savings options;</p> <p>(D) describe how to allocate a weekly allowance among spending, saving, including for college, and sharing; and</p> <p>(E) describe the basic purpose of financial institutions, including keeping money safe, borrowing money, and lending money.</p>
